Right of Withdrawal and Model Withdrawal Form for the User Agreement

(applies to consumers within the meaning of § 13 of the German Civil Code (BGB))

Right of Withdrawal

You have the right to withdraw from this contract within fourteen days without giving any reason.

The withdrawal period is fourteen days from the date of conclusion of the contract (registration on the iMonial platform).

To exercise your right of withdrawal, you must inform us

of your decision to withdraw from this contract by means of a clear statement (e.g. a letter sent by post or an email). You may use the model withdrawal form below for this purpose, but it is not mandatory.

You may also declare the withdrawal via the electronic withdrawal function on our website (see References). If you use this option, we will send you a confirmation of receipt of such withdrawal without delay (e.g. by email).

To meet the withdrawal deadline, it is sufficient that you send your notification of the exercise of the right of withdrawal before the withdrawal period has expired.

Consequences of Withdrawal

If you withdraw from this contract, we shall reimburse all payments received from you without delay and at the latest within fourteen days from the day on which we received the notification of your withdrawal of this contract. For this reimbursement, we will use the same means of payment that you used for the original transaction, unless expressly agreed otherwise with you; in no case will you be charged any fees for this reimbursement.

If you requested that the services should commence during the withdrawal period, you shall pay us a reasonable amount corresponding to the proportion of the services already provided up to the point in time at which you inform us of the exercise of the right of withdrawal with regard to this contract, compared to the total scope of the services provided for in the contract.

After withdrawal, your user account and all associated data will be deleted, with the exception of data that must be retained by law (see § 10(4) of the Terms of Service). Campaign Agreements that have already been concluded remain unaffected by the withdrawal of the user contract and will be settled in accordance with their own terms.
